FCL.025 Theoretical knowledge examinations for the issue of licences

- (a) Responsibilities of the applicant
 - (1) Applicants shall take the entire set of examinations for a specific licence or rating under the responsibility of one Member State.
 - (2) Applicants shall only take the examination when recommended by the approved training organisation (ATO) or declared training organisation (DTO) responsible for their training, once they have completed the appropriate elements of the training course of theoretical knowledge instruction to a satisfactory standard.
 - (3) The recommendation by an ATO/DTO shall be valid for 12 months. If the applicant has failed to attempt at least one theoretical knowledge examination paper within this period of validity, the need for further training shall be determined by the ATO, based on the needs of the applicant.

THEORETICAL KNOWLEDGE COURSE CERTIFICATION

This section is to be completed by the applicant's Ground / Flight Instructor and must be stamped with the Ground / Flight Instructor School's official stamp.

Applications received without the Ground Course Certification Stamped and signed (first time applications only), or without the correct fee will be returned to the applicant.

Important: For correspondence purposes, please print in BLOCK CAPITALS your name and email address.

Application Forms should reach the Examination Unit at least 14 days before the examination date, Late applications may be refused or be subject to a late application fee supplement.

Note: Subject to any other conditions in PART-FCL / PART-SFCL as appropriate, an applicant shall be deemed to have successfully completed the theoretical knowledge examinations for the PPL (A or H) / SPL when awarded a pass in all parts within **18 months**. A pass in theoretical knowledge examinations will be accepted for the grant of a PPL/SPL during the **24 months** from the date of successfully completing the examinations.
